

Cancel a registered training contract (by all parties)

This form is used to apply to cancel a training contract as per Section 33 of the *Further Education and Training (FET) Act 2014*. **Parties must notify the Department of Employment, Small Business and Training (DESBT) or their Australian Apprenticeship Support Network provider within 14 days of agreeing to cancel.**

Note: There are options available that employers and apprentices or trainees may consider as an alternative to cancellation. These include:

- amending the employment mode of the training contract, for example from full time to part time
- amending the training contract to change the qualification
- temporarily or permanently transferring to another employer
- suspending the training contract
- completion.
