Section 6 – Unique Student Identifier

From 1 January 2015 students in Nationally Recognised Training in Australia require a Unique Student Identified (USI) and Training Providers will not be able to issue a Certificate and/or Statement of Attainment without your USI on file.

The USI will link students to their training records which are held in the national training database. Students will be able to access their records online, download them and share them with future training organisations electronically. With the student's permission, training organisations will be able to see their students' entire training record from 2015.

Training organisations will find it easier to assess pre-requisites and credit transfers and assess students' eligibility for government funded training places.
